

GENERAL INFORMATION
CNI Supercal™ is a secondary nutrient formulated with mannitol, a sugar acid that has the ability to form multi-bond water soluble complexes calcium and other nutrients. **CNI Supercal™** contains a special adjuvant that enhances penetration and translocation. **CNI Supercal™** is designed for use in a balanced fertility program for fruit trees, vegetables and row crops. Applied in a program of multiple applications throughout the growing season, it supplies calcium at or near the time it is need most to enhance yield and quality.

DIRECTIONS FOR USE
CNI Supercal™ is compatible with most pesticides. A jar test is always recommended. Mixing sequence: 1. water, 2. **CNI Supercal™**, 3. pesticide and/or fertilizer. Foliar application should be made early in the morning or late in the day for best results.

Follow directions as over application may result in phytotoxicity

RECOMMENDED RATES
 Optimum rate of application will vary between fields, depending on pH, organic matter content or the crop to be grown. For best results follow soil or plant analysis recommendations in consultation with a local agricultural authority. In the absence of test results, use the following guide:

Soil Application: Severe Deficiency: 4 to 6 qts. per acre; Moderate Deficiency: 2-5 qts. per acre; Maintenance: 1-2 qts per acre.

Foliar Application: Apply at the rate of 1-2 qts. per acre per application throughout the growing season for a total of 4 applications. Increase the rate or frequency if the deficiency is severe or for certain crops with a high calcium requirement. Use 20 GPA water.

Aerial Application: Apply at the rate of 1 qt. per acre in 5 gallons of water. intervals as necessary. For flowering plants, annuals and other ornamentals, spray 2-3 fluid ounces per 1,000 sq.ft. in sufficient water to thoroughly cover the foliage and soil surface around the plants.
