GENERAL RECOMMENDATIONS

For prevention and correction of Calcium deficiencies. Contains penetrants and translocation aids. Contains no chlorides.

For use in a balanced fertility program for all crops requiring Calcium.

Vegetables, Fruit Tree and Field Crops

Apply 2-4 pints CHEM-EXTRA-Ca per acre per application throughout the growing season. At least 3 applications are recommended. More frequent applications at 1.5 quarts per acre may be needed to correct deficiencies once they occur.

Ornamental Crops

Apply 2-4 pints CHEM-EXTRA-Ca per 100 gallons water. Cover foliage thoroughly to point of runoff.

Soil Application

Can be made pre-plant or sidedress at 1-2 gallons per acre.

Post Harvest Fruit Drench Application

Use 1.5 gallons CHEM-EXTRA-Ca per 100 gallons water.

Use a minimum 20 gallons water per acre with ground spray equipment. 5 gallons for aerial application. CHEM-EXTRA-Ca is non-corrosive.

Optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendation.
