GENERAL INFORMATION

CHEM-PLEX™ LIQUID ZINC is a proprietary blend of a soluble nutrients and an organic complexing agent so as to enhance and maintain availability and accelerate uptake by crops.

CHEM-PLEX™ LIQUID ZINC is non-phytotoxic and can be applied foliar to most crops. It is recommended for use throughout the season in a program of multiple applications for greater efficiency. This provides a continuous supply of vital nutrients at or near the time they are needed most.

DIRECTIONS FOR USE

CHEM-PLEX™ LIQUID ZINC can be added to most nitrogen solutions or fluid fertilizers without premixing. It can be tank mixed with most pesticides. Always make a small-scale test to assure compatibility. It can be soil or foliar applied, broadcast or banded over the row and injected through irrigation systems. **CAUTION: DO NOT USE IN HIGH PHOSPHATE "STARTER" OR "POP-UP" FERTILIZER MATERIALS SUCH AS 10-34-0.**

CHEM-PLEX™ LIQUID ZINC will disperse in water with minimal agitation. It serves as a buffer when used in tank mixes with pesticides. Follow the mixing sequence: 1. Water; 2. **CHEM-PLEX™ LIQUID ZINC**; 3. Pesticide.

RECOMMENDED RATES

Broadcast Application:

Severe Deficiency	4 quarts per acre
Moderate Deficiency	2 quarts per acre
Maintenance	1 quart per acre

Row Application: Use at the rate of 2 quarts per acre as a supplement to broadcast fertilizer.

Foliar Application: Apply at the rate of 1-3 quarts per acre when crop is 6-12 inches high or when deficiency symptoms appear. Spray either early or late in the day for maximum leaf absorption.

WHAT TO DO IN CASE OF CONTACT

If Ingested: Give large amounts of water or milk if conscious. Contact a physician immediately.

Eye Contact: Flush eyes with clean water for 15 minutes. Seek medical attention immediately.

Skin Contact: Remove contaminated clothing and wash skin with soap and water. Seek medical attention if irritation develops or persists.

If Inhaled: Move to fresh air and seek medical attention if irritation develops or persists.
