**CHEM-SOL FOR PEANUT, COTTON AND SOYBEAN** is designed for crops such as Cotton, Peanuts, Soybeans and other agronomic crops.

**CHEM-SOL FOR PEANUT, COTTON AND SOYBEAN** is fortified with Sulfur and Manganese.

### DIRECTIONS FOR USE

**General Use:** 3 – 10 lbs per acre. Use this product as a foliar application to supplement the normal soil applied fertilizer program. Can be applied by aircraft at rates equivalent to 1 lb. to 1 gal. of water per acre. For back-pack sprayers use at the rate of 4 teaspoonful per gallon. For transplanting dissolve 5 lbs per 100 gallons of water.

Balanced nutrition is essential to optimum plant growth and yield. The addition of CNI AgriMinerals **Energy Booster**, a special blend of EDTA Chelated micronutrients and other nutritional components, can help to supply key micronutrients needed to achieve top performance. The recommended rate of **Energy Booster** should be used as shown on its label.
